**Short-Form Merger with Viaweb Inc.**

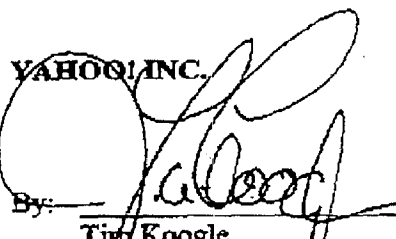
