## Exhibit A

### List of Trademarks/Tradenames

- United States Trademark Registration No. 2,130,621 granted January 20, 1998 for the trademark name **Pacific Isle** for live orchid plants in Class 31. Affidavit of use is due during the 6<sup>th</sup> year of registration and a renewal affidavit is due at the end of the first 10-year term.
- **The Orchid Experts** (Application Number 75/549,649). This has been applied for and the Patent Office has favorably acted upon the application. On February 22, 2000, the particulars were published in the Official Gazette for a 30 day opposition period. No oppositions were filed so a Notice of Allowance will be issued. After issuance, a Statement of Use needs to be issued.
- United States Trademark Registration No. 1,073,727 granted September 20, 1977 for the trademark name **Tru-Blue** for cut foliages for sale only at wholesale, in Class 31. Renewed on September 20, 1997 for 10 years. Affiliated with Eucalyptus.
- United States Trademark Registration No. 1,062,875, granted April 5, 1977, for the trademark name **Baby-Blue** for cut foliages and ornamental plants in Class 31. Renewed on April 5, 1997 for 10 years. Affiliated with Eucalyptis
- United States Trademark Registration No. 1,874,917 granted January 17, 1995 for the trademark name **Baby** for cut foliages in Class 31. This registration remains in force for 10 years.
