



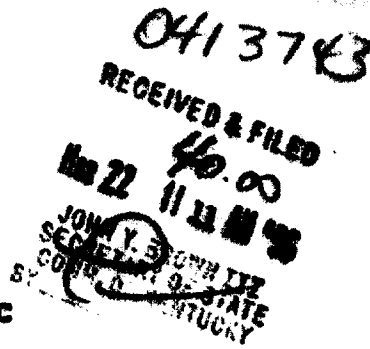

Articles of Organization  
of  
Carton Drive Enterprises, LLC



The undersigned hereby forms and organizes a limited liability company pursuant to the Kentucky Limited Liability Company Act and adopts the following Articles of Organization of such limited liability company:

**Article I**

The name of the limited liability company is:

Carton Drive Enterprises, LLC

**Article II**

**Article III**

**Article IV**

The limited liability company shall have at least two members.

**Article V**

The duration of the limited liability company shall be perpetual, save and until its dissolution in accord with the

Kentucky Limited Liability Company Act and the operating agreement of the limited liability company.

The management of the limited liability company is reserved to the members, to be exercised in accordance with the operating agreement of the limited liability company.

**Article VII**

The limited liability company was formed by the conversion of a general partnership organized pursuant to Kentucky law. The name of the general partnership was:
