ASSIGNMENT OF SERVICE MARK

THIS ASSIGNMENT OF SERVICE MARK (the "Assignment") is made and entered into, effective as of the 29th day of April, 1998, by USA Jet Airlines, Inc., a Delaware corporation ("Assignor") having its principal place of business at Hangar 2064 D Street, Willow Run Airport, Belleville, Michigan 48111, to and in favor of Air Transport International Limited Liability Company, a Nevada limited liability company ("Assignee"), pursuant to certain provisions of a Membership Interest Acquisition Agreement dated February 3, 1998, between Assignee and BAX Global Inc., a Delaware corporation.

WHEREAS, Assignor owned the United States service mark registration identified and set forth in Schedule A-1 attached hereto (the "Service Mark"), and the goodwill of the business associated therewith and any causes of action relating thereto;

WHEREAS, it was the intention of the parties that Assignor should assign to Assignee the Assignor's entire right, title and interest in and to the Service Mark;

Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks to record Assignee as the owner of the Service Mark and to issue to Assignee, in lieu of Assignor, in accordance with this instrument, all future certificates, notices and any other documents bearing on the Service Mark.

This instrument shall inure to the benefit of Assignee and its successors and assigns and shall be binding upon Assignor and its successors and assigns.
