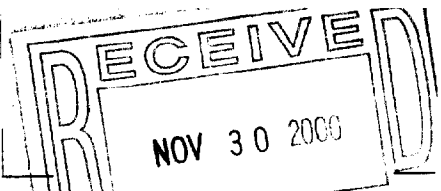

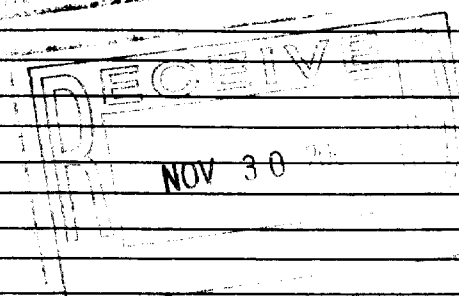

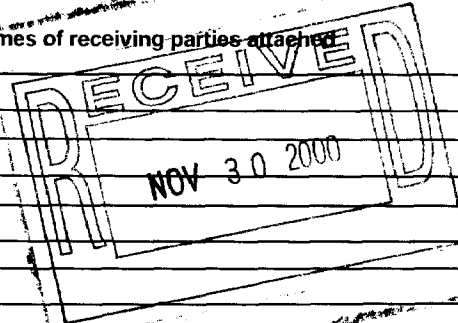

**RELEASE AND REASSIGNMENT OF A CONTINUING  
SECURITY INTEREST IN AND COLLATERAL ASSIGNMENT OF  
PATENTS, TRADEMARKS, COPYRIGHTS AND LICENSES**

THIS RELEASE AND REASSIGNMENT OF A CONTINUING SECURITY INTEREST IN AND COLLATERAL ASSIGNMENT OF PATENTS, TRADEMARKS, COPYRIGHTS AND LICENSES (this "Release") is made as of this 8<sup>th</sup> day of June, 1995, by and between Sanwa Business Credit Corporation, a Delaware corporation, as Agent for the benefit of all Lenders (the "Agent"), and The Crosby Group, Inc., a Delaware corporation (the "Assignor").

WITNESSETH:

WHEREAS, Assignor and Agent are parties to the Continuing Security Interest and Collateral Assignment of Patents, Trademarks, Copyrights and Licenses dated as of September 30, 1994 (the "Assignment").

NOW, THEREFORE, in consideration of the premises set forth herein and good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

1. All capitalized terms used herein, but not otherwise defined herein, are used as defined in the Assignment.

2. Agent hereby releases and reassigns to Assignor all of its right, title and interest in and to the collateral of Assignor identified and/or described in the Assignment (the "Collateral") including the Collateral listed in Schedules A, B and C to the Assignment which schedules are attached hereto; and Agent hereby releases any and all security interests it may have in the Collateral.

3. Agent shall cooperate with and assist Assignor and its assigns and their authorized representatives and shall execute such documents and take such other and further action as shall be reasonably requested by Assignor or its assigns in order to vest in the Assignor or its assigns the entire right, title and interest in and to the Collateral, free from any and all liens and encumbrances of Agent, all at the sole cost and expense of Assignor.

4. The provisions of this Agreement are severable, and if any clause or provision shall be held invalid and unenforceable in whole or in part in any jurisdiction, then such invalidity or unenforceability shall affect only such clause or provision, or part thereof, in such jurisdiction, and shall not in any manner affect such clause or provision in any other jurisdiction, or any clause or provision of this Agreement in any jurisdiction.

5. The benefits and burdens of this Agreement shall inure to the benefit of and be binding upon the respective successors and permitted assigns of the parties.

6. The validity and interpretation of this Agreement and the rights and obligations of the parties shall be governed by the laws of the State of Illinois.

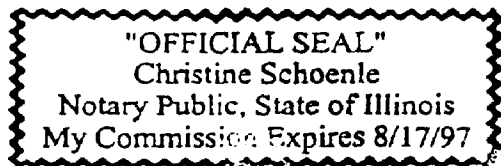
