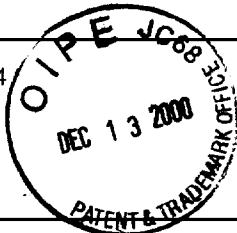

RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST is made by and between PNC Bank, National Association, formerly known as Midlantic Bank, N.A. (formerly known as Midlantic National Bank), with its office located at 2 Tower Centre Boulevard, 8th Floor, East Brunswick, New Jersey 08724 (hereinafter referred to as "THE BANK"), and Marcal Paper Mills, Inc., with its principal office located at One Market Street, Elmwood Park, New Jersey 07407 (hereinafter referred to as "BORROWER");

WHEREAS, THE BANK and BORROWER entered into an ASSIGNMENT FOR SECURITY (hereinafter referred to as "THE AGREEMENT") on June 27, 1995, which is recorded at Reel No. 1396, Frame No. 0165 at the Assignment Division of the U.S. Patent and Trademark Office against the trademarks shown in Exhibit A attached hereto;

WHEREAS, BORROWER has satisfied all of the obligations in the Agreement in full and has fully performed its covenants and undertakings under the Agreement as of September 11, 1997;

NOW THEREFORE, in consideration of the foregoing, THE BANK hereby nunc pro tunc, as of September 11, 1997, waives, releases, relinquishes and abandons any and all liens or security interests, and any and all claims of liens or security interests, of any kind or nature, including the ASSIGNMENT FOR SECURITY in and to all of the marks and THE BANK hereby authorizes and directs the Commissioner of the U.S. Patent and Trademark Office to release security interest in favor of THE BANK.

This release of security interest shall be binding upon THE BANK and its successors and assigns.
