

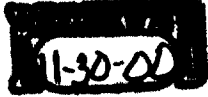



**ASSIGNMENT OF TRADEMARK**

(Tangent Growth Fund, L.P., and Tangent Fund Management II, LLC, Assignors)

This ASSIGNMENT OF TRADEMARK (this "Assignment") is made as of November 28, 2000 (the "Effective Date") by and between **Tangent Growth Fund, L.P.** and **Tangent Fund Management II, LLC** ("Assignors") and Aroma Candle & Scent Company Delaware corporation ("Assignee", and together with Assignors, the "Parties").

**WHEREAS**, Assignors have foreclosed on its security interest in certain assets of Big Wick Candle Company, Inc. and its predecessors in interest ("Big Wick") and, as a result thereof, is the sole owner of all rights, title and interest in and to the trademark entitled L'Assoluto, which was registered with the U.S. Patent and Trademark office on September 14, 1999 as registration number 2278401 (the "Mark"), and the goodwill and reputation of the business connected with and symbolized by the Mark;

WHEREAS, pursuant to a Bill of Sale and Assignment, dated the date hereof and executed by Assignor in favor of Assignee (the "Bill of Sale"), Assignee has purchased the assets of Big Wick from Assignor at a public auction held on November 28, 2000;

**WHEREAS**, Assignors wish to assign all rights, title and interest in and to the Mark to Assignee, and Assignee wishes to accept such assignment;

**NOW, THEREFORE**, in consideration of the mutual agreements, provisions and covenants contained herein, the Parties agree as follows:

**1. Assignment.** In consideration for the payment of all sums listed under the Bill of Sale, Assignor hereby transfers, conveys and assigns to Assignee all right, title and interest throughout out the world in and to the Mark, together with (a) all national, foreign, state and common law registrations, applications for registration and renewals and extensions thereof, and (b) all goodwill associated therewith (collectively, the "Rights"). Assignors will immediately discontinue use of the Mark throughout the world in all forms and media.


**2. Transfer of Rights.** Assignors will take all steps reasonably requested by Assignee to transfer the Rights to Assignee, including, without limitation, executing all of the forms required to be filed with the United States Patent and Trademark Office (the "PTO") or other appropriate individuals or entities.


