On June 5, 2000, we issued a press release and a waiver solicitation statement, copies of which are filed herewith as Exhibits 99.1 and 99.2, respectively, and are incorporated herein by reference, announcing the commencement of a waiver solicitation relating to our 10% Senior Notes due 2005 and our 11 1/2% Senior Notes due 2008. We intend to issue a press release



announcing the results of the waiver solicitation as promptly as practicable following the expiration of the waiver solicitation at 1:00 p.m., New York City time on June 13, 2000. Regardless of the outcome of the waiver solicitation, we and Metamor Worldwide, Inc. intend to hold the special meetings of shareholders of PSINet and Metamor on June 15, 2000 to vote on the merger and the other actions outlined in our joint proxy statement/prospectus dated May 12, 2000, and, subject to the terms and conditions of the merger agreement, to proceed with the merger.
