JOINT STIPULATION AND RELEASE

This Joint Stipulation and Release is made and agreed between Plaintiff Trademark Opposer, Argus Industries, Inc. ["Opposer Argus/Licensors"] of 1100 Howard, Elk Grove Village, IL 60007, and Defendant Trademark Applicant, K. J. Law Engineers, Inc. ["Applicant Engineers/Licensee"] of 42300 W. Nine Mile Rd., Novi, MI 48375, pursuant to a Confidential Trademark License Agreement between the above parties, in order to effect a just and amicable settlement of the trademark opposition dispute and to compromise and adjust said dispute without resorting to continued litigation.


In consideration of mutual agreements, covenants, and promises set forth in said Confidential License Agreement, and set forth in pertinent part in this Joint Stipulation and Release agreement, and other good and valuable consideration:

- a. Opposer Argus/Licensors agrees that it will, within ten(10) business days after signature of the said Confidential License Agreement by both parties, file an official Stipulated Motion of Voluntary Dismissal of its consolidated Opposition No. 114,531 in the U. S. Patent and Trademark Office U. S. Patent and Trademark Office and provide copies of such Stipulated Dismissal Motion to Applicant Engineers/Licensee at the above given address and to Applicant Engineers/Licensee's counsel.
- b. Applicant Engineers/Licensee, in further mutual consideration, agrees to approve, join in, and sign as necessary the above Stipulated Dismissal Motion at the time and date of signature of the said Confidential License Agreement, and also agrees to: (i) withdraw and abandon expressly its pending trademark Application for "ARGUS" Serial No. 75-430336 ["ARGUS"] by sending written notice of abandonment to the U. S. Patent and Trademark Office ("U.S.P.T.O.") and providing copy of same (with evidence of mailing/filing) to Licensors at or before the date of signing this License Agreement., and (ii) assign in full to Licensors (following the making and filing by Licensee of a complete, accepted Allegation of/or Statement of Use by Licensee with the U.S.P.T.O.) the pending trademark Application for "ARGUSLAB" Serial No. 75-430334 ["ARGUSLAB"]. This non-confidential Joint Stipulation and Release may be filed by the parties with the U. S. Patent and Trademark Office in carrying out the covenants of the Joint Stipulation and Release

- c. In consideration of all the above, Opposer Argus/Licenser and Applicant Engineers/Licensee hereby mutually release each other from any and all existing and potential legal claims, defenses, counterclaims, actions, interests, and equities of any and all types originally presented, reserved, or arising under this Opposition proceeding.





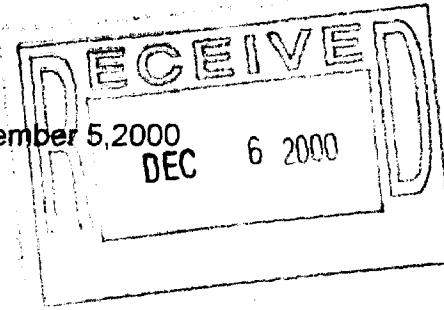
