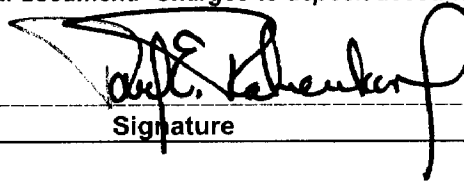

RESTATED CERTIFICATE OF INCORPORATION OF  
MODEL T1, INC.**

Model T1, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation")

DOES HEREBY CERTIFY:

**FIRST:** The name of the Corporation is Model T1, Inc.

**SECOND:** The date on which the Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of Delaware is December 14, 1999, under the name of Model T1, Inc.

**THIRD:** That the Board of Directors of the Corporation adopted a resolution setting forth a proposed amendment to the Restated Certificate of Incorporation, declaring said amendment to be advisable and in the best interests of the Corporation:
