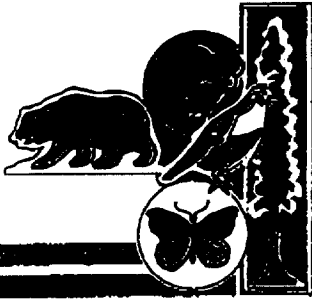

2. ARTICLE I of the Articles of Incorporation of this Corporation is amended to read as follows:


"The name of the Corporation is CL CINEMA LINE FILMS CORPORATION."


3. The foregoing Amendment of Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.
