

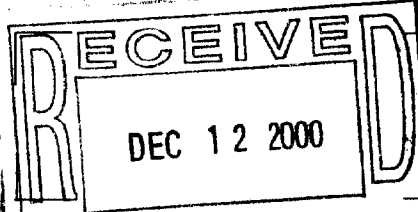

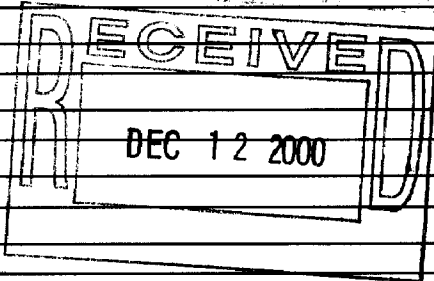


WHEREAS, Purchaser has acquired certain business assets of Seller, including, without limitation, the Marks and appurtenant goodwill.
