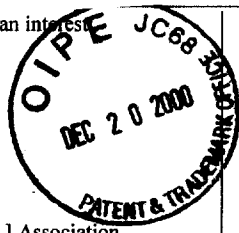

This also certifies that the Court has authorized the implementation of the merger agreement of Kymmene Oy (parallel company name, in English: Kymmene Corporation) reg no 5.807 and Repola Oy reg no 505.251. The companies have merged by founding a corporation called UPM-Kymmene Oy. The articles of association were accepted as a part of the merger agreement made by the companies on 11 September 1995 at the shareholders' meeting of Kymmene Oy on 1 November 1995 and at the shareholders' meeting of Repola Oy on 31 October 1995.
