Scan-Optics, Inc., a corporation incorporated pursuant to the provisions of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify that it owns all of the capital stock of Southern Computer Systems, Inc. ("Southern"), a corporation incorporated under the laws of the State of Alabama, and that, by resolutions of its board of directors duly adopted at a meeting held on the 26th day of January, 1999, it approved the merger of Southern with and into it, which resolutions are as follows:

RESOLVED: That it is advisable and in the best interests of the Corporation to merge Southern Computer Systems, Inc., an Alabama corporation, all of whose outstanding shares of stock are owned by the Corporation, into the Corporation and thereby to assume all of its assets and obligations pursuant to the corporation laws of the States of Delaware and Alabama.

RESOLVED: That the Authorized Officers are hereby severally authorized and directed, by and on behalf of the Corporation, to execute, acknowledge and file with the Secretary of the State of Delaware at such time as the Authorized Officer so acting determines to be appropriate, in the name and on behalf of the Corporation, a certificate of ownership and merger as referred to in Section 253(a) of the Delaware General Corporation Law setting forth a copy of the resolution to merge Southern into itself and assume its assets and obligations, and the date of adoption thereof, in such form as the Authorized Officer executing it may approve, such approval to be conclusively evidenced by his execution and delivery of it.
