

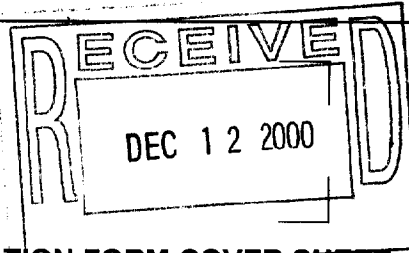

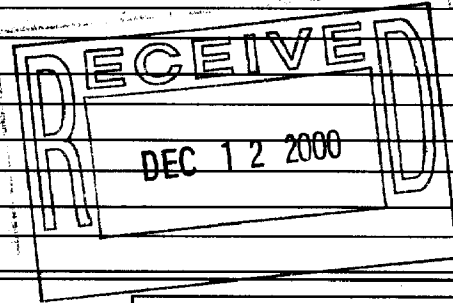


WHEREAS, ASSIGNOR has adopted and is using the trademark listed in Appendix B for which it owns a state registration;
