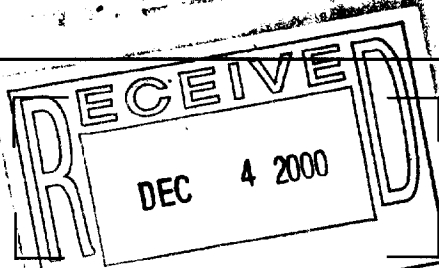

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR assigns to ASSIGNEE all right, title and interest in and to the Trademarks and the applications in the United States and throughout the world together with the common law rights and goodwill of the business symbolized by the Trademarks and together with the right to recover for damages and profits from past infringements thereof, if any. The Commissioner of Patents and Trademarks is requested to issue the Certificates of Registration to the ASSIGNEE.
