

#### TERMINATION OF SECURITY AGREEMENT

This TERMINATION OF SECURITY AGREEMENT (this "Termination") is made as of the 17/12 day of November, 2000 by and between The Collaborative Group, Ltd., a Delaware corporation having a usual place of business at Fifty East Loop Road, Stony Brook, New York 11790 (hereinafter "TCG"), the Rhode Island Economic Development Corporation, a public corporation, governmental agency and public instrumentality of the State of Rhode Island with a principal place of business at One West Exchange Street, Providence, Rhode Island 02903 (hereinafter "RIEDC") and Citizens Bank of Rhode Island, as trustee (the "Trustee").

WHEREAS, TCG, RIEDC and the Trustee entered into one or more Security Agreements, each dated July 30, 1999 (the "Security Agreements"), pursuant to which TCG granted RIEDC and the Trustee a security interest in collateral therein identified, as detailed on Exhibit A hereto (the "Collateral"), in order to secure the obligations of TCG under that certain Lease and Loan Agreement dated as of July 30, 1999 by and between the RIEDC and Collaborative Smithfield Corp. ("CSC") an affiliate of TCG (the "Obligations").

WHEREAS the Obligations have been discharged with respect to CSC and the parties wish to evidence in writing the termination of the Security Agreement and the security interests granted thereunder.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and adequacy of which is acknowledged by the parties hereto, the parties hereby agree as follows:

- 1. The Security Agreements and all security interests in and to the Collateral are hereby terminated and of no further force and effect. RIEDC and the Trustee consent to the filing of this Agreement with any appropriate authority and shall execute and deliver such further documents and take such actions as TCG may reasonably request in order to evidence the termination of such security interests.
- 2. This Termination shall be governed by and construed in accordance with the laws of the State of Rhode Island (without giving effect to its conflict of laws principles thereof).
- 3. This Termination may be executed in any number of counterparts and by the different parties hereto on separate counterparts, each of which when So executed and delivered shall be an original and all of which shall together constitute one and the same agreement.




