

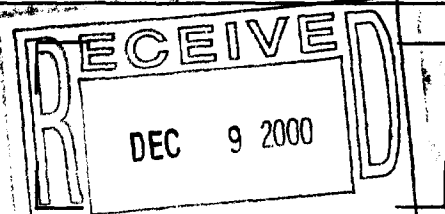

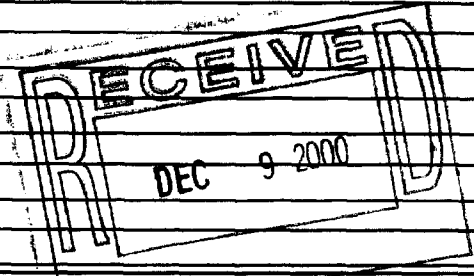

DOES HEREBY CERTIFY:

FIRST: the Corporation was incorporated on December 9, 1999 pursuant to the DGCL.

SECOND: That liveprint.com, inc. ("Liveprint") was incorporated on August 29, 1997 under the DGCL.
