WHEREAS, H-Tech, Inc., a corporation organized and existing under the laws of the State of Delaware and having a place of business at 103 Springer Building, 3411 Silverside Road, Wilmington, Delaware 19810 (hereinafter referred to as the "ASSIGNEE"), is desirous of acquiring the entire right, title and interest of the ASSIGNOR in and to said trademark application, including any and all rights in the trademark to which said application is directed, the goodwill symbolized thereby and any Registration that issues from said application or relates to said trademark.

NOW, THEREFORE, for One Dollar (US\$1.00), and other good and valuable consideration, the receipt of which is hereby acknowledged, the ASSIGNOR hereby sells and assigns to the ASSIGNEE, its successors, assigns and legal representatives, the entire right, title and interest of the ASSIGNOR, in and to said trademark application and said trademark to which said application is directed, the goodwill symbolized thereby and any Registration that issues from said application or relates to said trademark (hereinafter collectively referred to as the "ASSETS") together with all unsatisfied claims for damages by reason of past infringement of said trademark and the right to sue for and collect same.

The ASSIGNOR hereby constitutes and appoints the ASSIGNEE, its successors and assigns, the true and lawful attorney or attorneys of the ASSIGNOR, with full power of substitution, for it and in its name and stead or otherwise, but at the sole expense and on behalf of and for the benefit of ASSIGNEE, its successors and assigns, to institute and prosecute, from time to time, any proceedings at law, in equity or otherwise, that ASSIGNEE, its successors or assigns, may deem proper in order to assert or enforce any claim, right or title of any kind in and to the ASSETS hereby sold and transferred, and to defend and compromise any and all actions, suits or

proceedings in respect of any of said ASSETS, and, generally, to do any and all such acts and things in relation thereto as ASSIGNEE, its successors or assigns, shall deem advisable, including, but not limited to, the execution and delivery of any and all assignments and instruments in furtherance hereof. The ASSIGNOR declares that the appointment hereby made and the powers hereby granted are coupled with an interest and shall be irrevocable by the ASSIGNOR.

This instrument and all of its terms shall inure to the benefit of and shall bind the ASSIGNOR and ASSIGNEE and their respective successors and assigns.
