

IN WITNESS WHEREOF, said Assignor has caused these presents to be executed by an officer thereof, thereunto duly authorized this 2nd day of November, 2000.

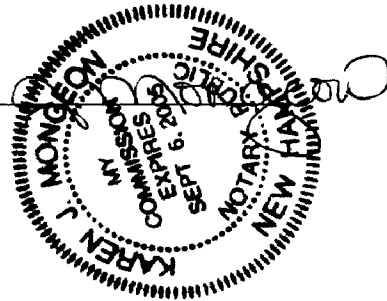
