

Notwithstanding anything in this Agreement to the contrary, Assignee acknowledges and agrees that, unless and until an Event of Default has occurred and is continuing, this Agreement shall constitute a collateral assignment, and not an absolute assignment, of Assignor's right, title and interest in the Trademark Collateral.


