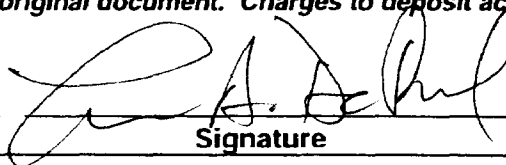

2. Article I of the Articles of Incorporation of the corporation is hereby amended to read as follows:

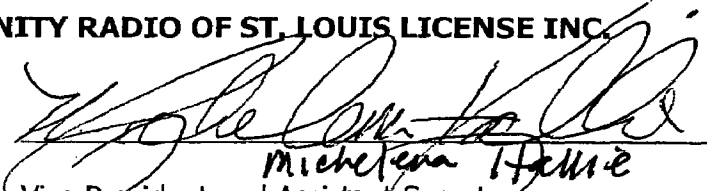
"The name of the Corporation is: Infinity Radio of St. Louis License Inc."

2. Article I of the Corporation's Articles of Incorporation shall be deleted in its entirety, and a new Article I shall be inserted in its place, which shall read as follows:

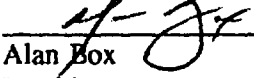
