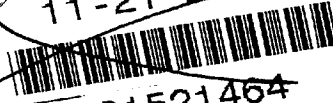

Addendum Number Two (2) to the
License Agreement
between
BEST BUY CONCEPTS, INC.
and
BEST BUY CO., INC.

WHEREAS Best Buy Concepts, Inc. and Best Buy Co., Inc. have entered into a License Agreement ("Agreement") dated March 5, 1996;

WHEREAS Best Buy Concepts, Inc. and Best Buy Co., Inc. desire to modify the terms and conditions of the Agreement by way of this Addendum ("Addendum");

NOW, THEREFORE, Best Buy Concepts, Inc. and Best Buy Co., Inc. agree as follows:

1. In the event of conflict between the terms and conditions of the License Agreement and the terms and conditions of this Addendum, the terms and conditions of this Addendum will govern and control. The headings used in this Addendum are included for convenience only and are not to be used in construing or interpreting the Addendum. All capitalized terms used herein shall have the meaning assigned thereto in the Agreement unless expressly provided otherwise herein.

2. **Preamble.** With respect to the Preamble, the parties acknowledge that following the restructure on March 5, 1996, simultaneous or approximately at the same time as the effective date of the Licensing Agreement, Best Buy Co., Inc.'s owns and operates retail stores only in Minnesota.

3. **Section 1.03, Royalty Fee, Typographical error and Change in Payment Method.** The parties acknowledge the typographical error in Section 1.03 Royalty Fee of the License Agreement. In the first line, the second reference to Licensee should be to Licensor. Further, as of February 28, 1999, the Section 1.03 is deleted in its entirety and replaced with the following:

Section 1.03 Royalty Fee. The Licensee shall Pay the Licensor for the use of the licensed property under this Agreement an amount equal to one and one half percent (1.5%) of the gross receipts of each Store. The amount owed by the Licensee shall accrue and the amount accrued and owed as of the end of the third fiscal quarter shall be paid during Licensee's fourth fiscal quarter. Licensee may deduct from such payment any amounts owed as of the end of the third fiscal quarter by the Licensor to the Licensee at the time of payment.
