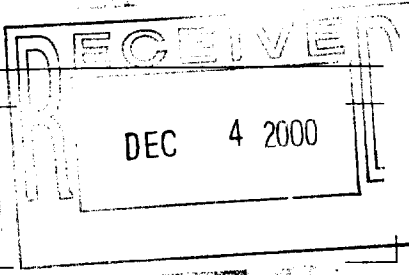

## **TRADEMARK ASSIGNMENT**

This Assignment is made between Transcender Corporation, a Tennessee corporation ("Assignor"), and Transcender LLC, a Delaware limited liability company ("Assignee").

WHEREAS Assignor owns the trademark applications and registrations on the Principal Register of the United States Patent and Trademark Office ("PTO") listed on Schedule A hereto (collectively the "Trademarks");

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement dated on even date herewith (the "Asset Purchase Agreement");
