FURTHER, Assignor agrees to execute and provide promptly after its execution hereof such further instruments and documents and assignments as may be reasonably necessary to effectuate the purpose of this Assignment and to enable Assignee to record in Assignee's name all of Assignor's rights in and to the mark with the Commissioner for Trademarks or any other appropriate governmental agency.
