## ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement ("Agreement") is made and entered into as of the close of business on October 31, 1999 by and between Record Town Michigan, Inc., a Delaware corporation ("Michigan") and Trans World New York, LLC, a New York limited liability company ("TWNY").

WHEREAS, all of the membership interests of TWNY are wholly owned by Michigan;

and  
WHEREAS, prior to entering into this Agreement, Michigan's sole shareholder, Record Town, Inc. ("Record Town"), came into possession of the rights to all of the assets of Camelot Music, Inc., a Pennsylvania corporation ("Camelot"), Camelot Midwest Region, Inc., a Delaware corporation ("Midwest"), Camelot Northeast Region, Inc., a Delaware corporation ("Northeast"), Camelot Southeast Region, Inc., a Delaware corporation ("Southeast"), and Camelot Western Region, Inc., a Delaware corporation ("Western"), (Midwest, Northeast, Southeast and Western sometimes referred to collectively herein as the "Camelot Subsidiaries" and individually herein as a "Camelot Subsidiary"); and

WHEREAS, Record Town transferred a portion of those assets to Michigan, including certain assets defined herein as the "Camelot Marks"; and

WHEREAS, Michigan now wishes to assign the Camelot Marks to TWNY, upon the terms and conditions set forth herein; and

WHEREAS, TWNY agrees to accept the Camelot Marks and assume any associated liabilities, upon the terms and conditions set forth herein.

NOW, THEREFORE, for and in consideration of the premises and for other good and valuable consideration, it is agreed:

1. **Assignment.** Michigan hereby assigns, transfers and conveys to TWNY all of Michigan's right, title and interest in and to the Camelot Marks, as that term is defined in section 2 hereof.

2. **The Camelot Marks.** The "Camelot Marks" as that term is used herein shall mean all trade marks, service marks and other intellectual property, and any and all registrations thereof, together with the associated goodwill, and all rights, licenses and royalties thereto, formerly belonging to Camelot, and to the Camelot Subsidiaries, or any subsidiaries or predecessors in interest thereof, which Camelot Marks are listed on the attached Schedule A hereof.

3. **Acceptance and Assumption.** TWNY hereby accepts the Camelot Marks and any rights attendant thereto and assumes all liabilities and obligations in connection therewith and agrees to perform all of the terms, conditions and covenants thereunder.

4. **Registration.** The parties agree to cooperate in promptly registering the Camelot Marks in the name of TWNY. In the interim, TWNY may exercise all rights of sole ownership

in the Camelot Marks, and Michigan shall cooperate in carrying out TWNY's wishes with respect thereto.

5. **Consent by Record Town.** Record Town hereby consents to the this assignment to TWNY, and shall execute this Agreement to indicate such consent.

6. **Amendment.** This Agreement may be amended by an instrument in writing signed on behalf of each of the parties hereto.


7. **Entire Agreement.** This Agreement constitutes the entire agreement and supersede all prior agreements and understandings, both written and oral, among the parties with respect to the subject matter hereof.

8. **Governing Law.** This Agreement and the legal relations between the parties hereto will be governed by and construed in accordance with the laws of the State of New York, without giving effect to the choice of law principles thereof.


9. **Assignment.** This Agreement and any of the rights, interests or obligations hereunder may only be assigned in writing and upon written consent of both parties.
