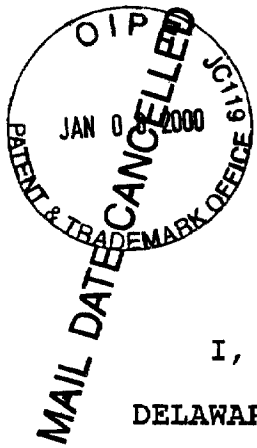

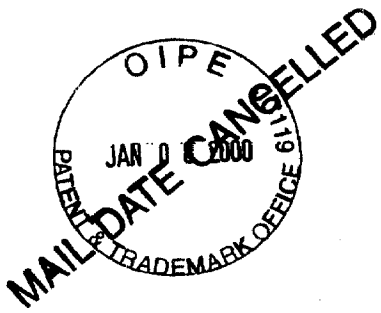

The undersigned corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the name and state of incorporation of each of the constituent corporations to the merger are as follows:

<u>Name</u>	<u>State of Incorporation</u>
Creoproofer Inc. (the "Company")	Delaware
Iris Graphics, Inc. ("Iris Graphics")	Massachusetts

SECOND: That the Agreement and Plan of Merger, dated as of April 3, 2000, among the Company and Iris Graphics (the "Merger Agreement"), has been approved, adopted, certified, executed and acknowledged by each of the Company and Iris Graphics in accordance with the requirements of Section 252 of the General Corporation Law of the State of Delaware (the "DGCL"). In the case of the Company, the Merger Agreement was adopted by the written consent of the sole stockholder of the Company in accordance with Section 228 of the DGCL.

THIRD: The surviving corporation of the merger is Creoproofer Inc., whose name shall change to Iris Graphics, Inc.

FOURTH: That the certificate of incorporation of the Company shall be the certificate of incorporation of the surviving corporation.


FIFTH: That the executed Merger Agreement is on file at the principal place of business of the surviving corporation. The address of the principal place of business of the surviving corporation is 6 Crosby Drive, Bedford, MA 01730.

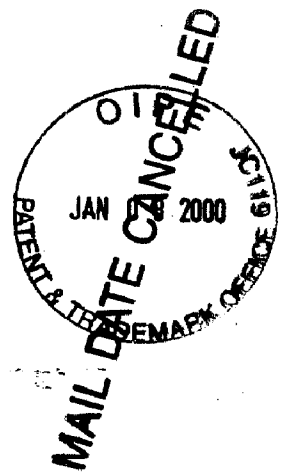
SIXTH: That a copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder of the Company or Iris Graphics.
