

BETWEEN:

- (1) **J.H. FENNER & CO LIMITED** (No. 527331) whose registered office is at Hesslewood Country Office Park, Ferriby Road, Hessle, East Yorkshire HU13 0PW ("Assignor"); and
- (2) **GENERAL SIGNAL UK LIMITED** (No. 517486), whose registered office is at London Road South, Poynton, Stockport SK12 1LH (the "Assignee").

THE PARTIES AGREE as follows:

1. **DEFINITIONS**

In this Agreement:

"Trade Mark" means the trade mark registered in the United States of America listed in the schedule to this Assignment of which the Assignor is the registered proprietor;

2. **ASSIGNMENT**

In consideration of the sum of £500 (five hundred pounds) now paid by the Assignee to the Assignor (the receipt of which the Assignor hereby acknowledges)

2.1 The Assignor hereby assigns and transfers to the Assignee absolutely with full title guarantee

2.1.1 all right, title and interest in and to the Trade Mark including all statutory and common law rights attaching to the Trade Mark and all the rights, powers, liberties and immunities attaching to the Trade Mark, free from all liens, charges and encumbrances including the right to sue for and to recover damages and other remedies in respect of any infringement of or other acts of passing off in respect of the Trade Mark which may have occurred before the date of this Assignment; and

2.1.2 the goodwill attaching to the Trade Mark and the goodwill of the business in the goods/services in respect of which the Trade Mark are used.

3. **FURTHER ASSURANCE**

The Assignor shall on request by the Assignee in writing and at the Assignee's expense do and execute or arrange for the doing and executing of, each necessary act, document and thing reasonably within its power to implement this Assignment.

4. **ASSISTANCE WITH PROCEEDINGS**

If proceedings are instituted by way of claim, petition or counter-claim impugning the validity of the registration of the Trade Mark within 12 months of the date of this Assignment the Assignor shall give all reasonable assistance to the Assignee in relation to those proceedings subject to the payment by the Assignee of all the Assignor's reasonable costs in relation to those proceedings.



5. **GOVERNING LAW**

The Assignment is governed by, and shall be construed in accordance with, English law.



