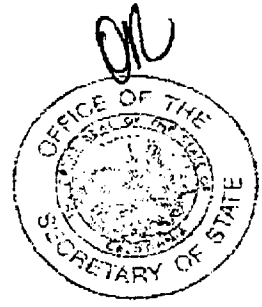

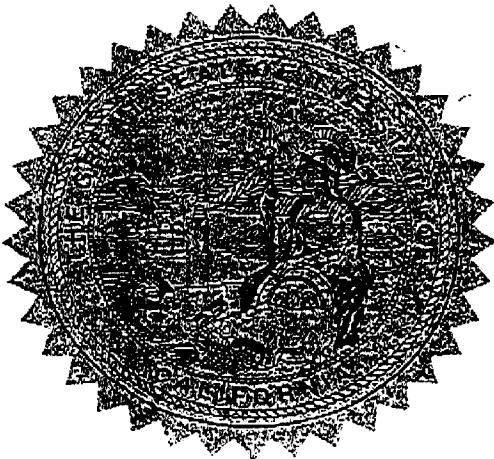

"FIRST: The name of this Corporation is: Porex Medical Products, Inc."

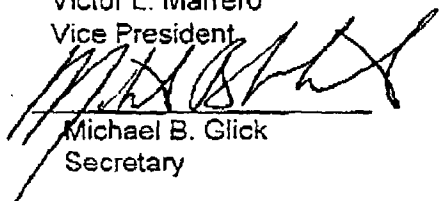

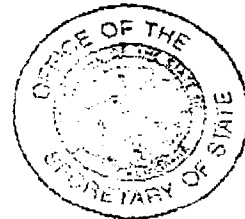
