TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is made by and between CompUSA Inc., a Delaware corporation, having its principal offices at 14951 North Dallas Parkway, Dallas, Texas 75240, U.S.A. ("Assignor") and CompUSA Management Company, a Delaware business trust, having its principal offices at 14951 North Dallas Parkway, Dallas, Texas 75240, U.S.A. ("Assignee").

WITNESSETH

Whereas, Assignor has adopted, used, is using or intends to use and is the owner of the trademarks and trademark applications listed on attached Exhibit A (the "Marks");

Whereas, Assignor has agreed to assign and Assignee has agreed to acquire all of Assignor's right, title and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof; and

Now, therefore, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys unto Assignee all of Assignor's right, title and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof.
2. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and the State of Texas.
