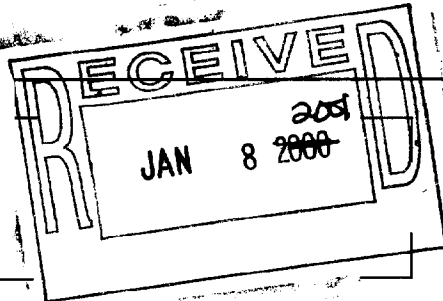

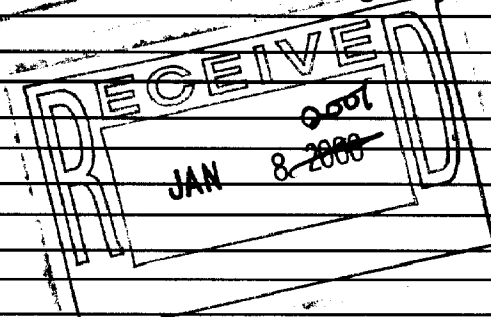

WHEREAS, Assignee desires to obtain, and Assignor agrees to assign, all right, title and interest in and to the Trademarks according to the terms of this Agreement.




