

Whereas, Cindy Evans Voorhees, a resident of the State of California, of 5912 Edmonds Circle, Huntington Beach, California 92649, (the "Assignor") has adopted, used and is using the trademark PARABLES JEWELRY & ACCESSORIES which is registered in the United States Patent and Trademark Office, Registration No. 2,248,326, dated May 25, 1999, (the "Mark"), and

Whereas, The Parable Group, Inc., a California Corporation, of 3563 Empleo Street, San Luis Obispo, California 93401-7325 (the "Assignee") is desirous of acquiring the Mark and the registration thereof together with all other similar trademarks and service marks and all goodwill associated therewith;

Now, therefore, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Assignor hereby agrees as follows:

- 1. Assignor does hereby assign unto Assignee all of Assignor's right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark and the above identified registration thereof.
- 2. Assignor does hereby assign unto Assignee all of Assignor's right, title and interest in and to any other trademark or service mark which includes one or more words (i) contained within the Mark; or (ii) similar to those words contained within the Mark (without intending to limit the foregoing, examples of such trademarks and service marks are PARABLES, PARABLES JEWELRY, PARABLE'S and PARABLE) and any other trademark or service mark similar to the Mark, together with the goodwill of the business symbolized by any and all such marks.
- 3. Assignor hereby assigns to Assignee all of her right, title and interest in and to the artwork associated with the Mark on packaging, labels, cards and advertising. Assignor agrees that this Assignment shall also operate as an assignment and conveyance of title to Assignee as to any revisions to such artwork or to any new logos or designs Assignor may develop in the future with respect to the Mark, itself. Nothing contained in this Assignment, however, shall be construed as an assignment by the Assignor to Assignee of any of her rights, title or interest in and to the designs she has created for the jewelry products which have been sold in association with the Mark. All such jewelry designs, as well as any other jewelry design Assignor may create in the future, shall be and remain the sole and exclusive property of Assignor.
- 4. It is acknowledged that all assignments and conveyances made by Assignor pursuant to this Assignment are without restriction as to geographical territory and that such assignments convey all of the Assignor's rights in and to the Mark and such related marks throughout the entire world.
- 5. Assignor acknowledges that the monetary consideration for this Assignment has been paid in full by the Assignee, concurrent with the execution and delivery of this Assignment.

- 6. Assignor represents and warrants that Assignor has good and merchantable title in and to the Mark and that Assignor by these presents has conveyed good and merchantable title to the Mark and the registration thereof at the U.S. Patent and Trademark Office (Registration No. 2,428,326), free and clear of all liens, security interests, encumbrances and other claims. Assignor further represents and warrants that Assignor first used the Mark anywhere on September 15, 1998 and first used the Mark in interstate commerce on September 15, 1998. Assignor has used the Mark continuously in interstate commerce from and after September 15, 1998, through and including the date of this Assignment. The Mark has not been abandoned. Trademark Registration No. 2,248,326, is in good standing as of the date of this Assignment. Assignor has not licensed any third party to use the Mark.
- 7. Assignor retains unto herself the limited right to use the Mark for the sole purpose of disposing by sale or gift the remaining products she has on hand or within her control which bear the Mark, such right to exist for a time period not to exceed twelve (12) months from the date of this Assignment. The Assignor covenants that she will not permit any new or additional products to be manufactured, sold or distributed in connection with the Mark, nor will she license or permit any third parties to do so. Assignor acknowledges and agrees that except with regard to the limited right to sell existing product associated with the Mark, as set forth in this paragraph, Assignee has not licensed Assignor for any further or other use of the Mark.
- 8. The Parable Group, Inc., a California corporation, the Assignee in the forgoing Assignment, hereby enters this instrument for the sole purpose of releasing Assignor and any business or persons who have sold her products bearing the Mark from any trademark infringement claim Assignee may have had with respect to Assignor's or their previous use of the Mark as well as any limited future use which occurs within the parameters set forth in paragraph 7, above. Such release does not include any claim for reimbursement and indemnification relative to any product liability claims asserted against Assignee by third parties who have acquired products manufactured and sold, through or on behalf of Assignor.


