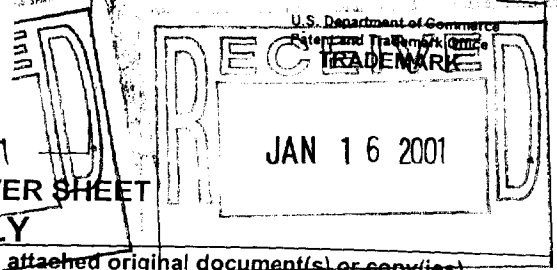

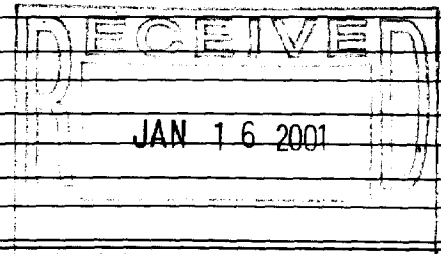

ASSIGNMENT


