This Trademark Assignment ("Agreement") dated December 28, 1999 is made between and among Fagerdala World Foams AB, trading as Fagerdala and being located in Sweden (FD) and Dan-Foam A/S, trading as Dan-Foam and being located in Denmark (DF).

FD is the owner of certain Tempur product related trademarks used by Tempur Pedic, Inc., a U. S. corporation. It is the parties' intention to effect the sale of the Tempur family of trademarks from FD to DF to be utilized for the benefit of Tempur-World, Inc. (TWI), the planned merged company consisting primarily of Dan-Foam A/S, certain newly formed European subsidiaries and Tempur-Pedic, Inc. A goal of TWI is to maximize the development, growth and profitability of the Tempur products. Thus, an important part of the plan to achieve these goals requires TWI to control the trademarks through its subsidiary, DF.

Therefore, for good and valuable consideration, the receipt of which is hereby acknowledged by FD, the parties have agreed to the assignment set forth below.

### **AGREEMENT**

- FD hereby sells, assigns and transfers to Dan-Foam A/S, its successors and assigns, all of FD's rights, interests, and title to the Marks, as identified below, together with the goodwill of the business symbolized by said Marks. The present assignment includes any rights FD may have to sue for past infringements and to collect proceeds from such infringements. The present assignment is effective as of the date of this Agreement. The Marks include all trademarks including the word "Tempur", including without limitation, the marks subject to the following registrations:

- The parties agree that this transaction represents a complete transfer of all Tempur related trademarks and that Tempur-World, Inc., through its subsidiaries, will have the exclusive rights to use the Tempur name and all related trademarks throughout the world.

5. The purchase price consideration for the Marks is to be DKK 50,000,000 payable in three installments as follows:

January 31, 2000	DKK 12,500,000
March 31, 2000	DKK 12,000,000

The purchase price payments shall consist of either cash payments to FD or an offset of existing liabilities between the parties, if any, as mutually agreed by the parties.


