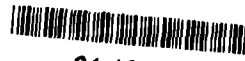

The name of this corporation (hereinafter called the "Corporation") is PREFERRED TECHNICAL SERVICES, INC.

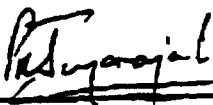
