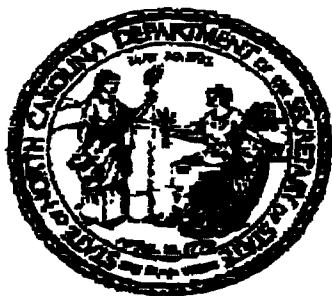

Pursuant to Section 55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation to change its corporate name:

1. The name of the corporation is Big Rock Sports, Inc.

2. The text of each amendment adopted is as follows:

**The name of the Corporation shall be changed to "BRS Investments, Inc."**

3. The amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

4. The date of adoption of the amendment was October 3, 2000.

5. The amendment was approved by shareholder action, as follows:


