**DECLARATION OF RICHARD T. STANGE**

I, Richard T. Stange, do hereby declare that:

1. I am the Senior Vice President and Deputy General Counsel of Jefferson-Pilot Corporation.

2. On February 27, 1997, the Chubb Corporation ("Chubb") entered into a Stock Purchase Agreement relating to the purchase and sale of Chubb Life to Jefferson-Pilot Corporation.<sup>1</sup> Pursuant to the Stock Purchase Agreement, a trademark assignment regarding CHUBBHEALTH was recorded on April 22, 1999.

3. Jefferson-Pilot hereby transfers the registered mark back to Chubb, and makes no objection to Chubb's registration of the CHUBBODYSEY mark.

4. I make this declaration to establish a proper link in the chain of title of the above referenced trademark and to assign ownership of the referenced mark.

5. I further declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements are made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful statements may jeopardize the validity of the above identified trademark.
