RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Release of Security Interest in Trademarks is granted and conveyed *nunc pro tunc* as of January, 1992 by CIT Group/Business Credit, Inc., a New York corporation, having an office at 1211 Avenue of the Americas, 21st Floor, New York, New York 10036 ("CITBC"), in favor of Sirco International Corp., a New York corporation, having its principal business address at 700 South Fulton Avenue, Mount Vernon, New York 10550 ("Sirco").

WHEREAS, the records of the United States Patent and Trademark Office ("PTO") reflect that Sirco and CITBC entered into a Trademark Collateral Assignment and Security Agreement ("Security Agreement") on January 12, 1980, under which Sirco granted to CITBC an assignment of Sirco's interest in certain trademarks listed on the attached Schedule A (the "Marks"), and any renewals of them.

WHEREAS, the PTO recorded this Security Agreement on June 12, 1990, at Trademark Reel 0716, Frame 0782;

WHEREAS, Sirco has satisfied all of its outstanding obligations under the security agreement, and the parties seek to make a record of CITBC's release and reassignment to Sirco of its security interests in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, CITBC hereby releases, discharges, and relinquishes, *nunc pro tunc* as of January, 1992, its security interests in the Marks, and reassigns to Sirco, *nunc pro tunc* as of January, 1992, all right, title, and interest that CITBC may have had in the Marks, including the goodwill associated with the Marks. CITBC specifically acknowledges that the security interests no longer are effective, and that CITBC does not own any rights to or have any ownership interests in the Marks.
