

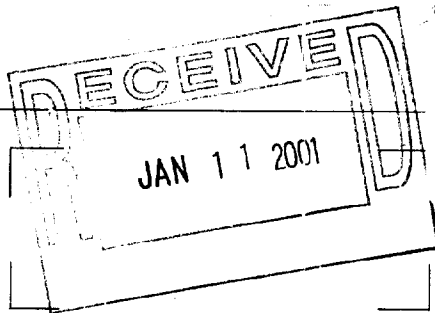

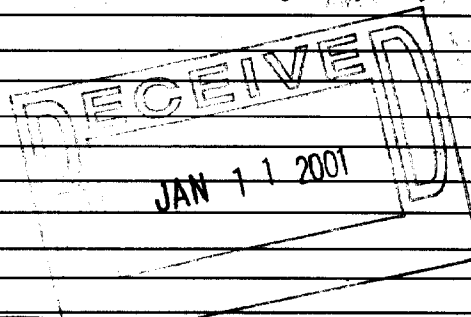

**Notice of Release of Lien on Trademarks**

This Notice of Release of Lien on Trademarks (the "Release") is executed this <sup>13<sup>th</sup></sup> day of December, 2000 by Citicorp USA, Inc., a Delaware corporation, as agent ("Agent") for the financial institutions party to the Credit Agreement dated as of May 20, 1994, among Barnett Inc., WOC Inc., Waxman Consumer Products Group Inc., Waxman USA Inc., the financial institutions party thereto and the Agent, in favor of Barnett Inc., a Delaware corporation ("Grantor").


