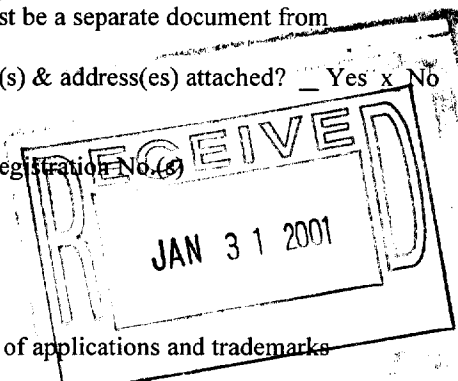

## NOTICE OF GRANT OF SECURITY INTEREST

WHEREAS, a Loan Agreement ("Loan Agreement") was entered into on September 1, 2000 by and between HealthMagic, Inc., a Delaware corporation, having a mailing address at 1501 Main Street, Columbia, South Carolina 29201 ("Borrower") and Adventist Health System Sunbelt Healthcare Corporation, a Florida non-profit corporation, having a mailing address at 111 North Orlando Avenue, Winter Park, Florida 32789 ("Adventist"), under which Borrower has assumed certain obligations to Adventist.

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, Assignor hereby grants to Adventist a security interest in and to all of its right, title and interest in and to the Marks, and the registrations thereof and pending applications therefor, listed in Schedule A attached hereto and as amended from time to time, and the goodwill of Assignor's business symbolized by each of said Marks.
