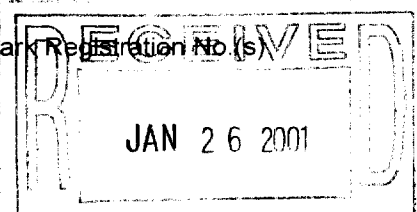

WHEREAS, the consideration for the foregoing transfer is represented in part by contractual and financial obligations and a promissory note from Rosenbloom to the Company; and


WHEREAS, Rosenbloom has executed a security agreement and financing statements giving the Company a security interest in the mark;
