CERTIFICATE OF AMENDMENT  
OF  
ARTICLES OF INCORPORATION  
OF  
D-7 EQUIPMENT COMPANY, INC.

The undersigned, being the duly elected, qualified and acting President and Secretary of D-7 Equipment Company, Inc., a Nevada corporation, hereby certify:

1. That August 1, 1996, at a special meeting of the directors of the corporation, the Board of Directors unanimously adopted the following resolutions:

RESOLVED: That it is deemed advisable that Article I of the Articles of Incorporation of D-7 Equipment Company, Inc. filed with the Secretary of State of Nevada on January 12, 1994, be amended to read in its entirety as follows:

"ARTICLE I

NAME

The name of the corporation shall be D-7 Manufacturing, Inc."

FURTHER RESOLVED: That a special meeting of the stockholders of the corporation shall hereby be called for the purpose of acting upon this amendment, of which meeting written notice is hereby directed to be given to each stockholder entitled to vote, in the manner and for the period of time prescribed by NRS 78.370 and by the Bylaws of this corporation.

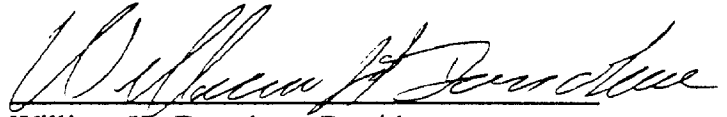
FURTHER RESOLVED: That if at such meeting of stockholders, or any adjournment thereof, stockholders entitled to exercise a majority of the voting power shall vote in favor of the amendment, or in the alternative, that stockholders having a majority of the voting power shall consent in writing to the amendment, in which event no meeting shall be called, noticed or held, then the corporation shall make, under the hands of its President, or Vice President, and Secretary, or Assistant Secretary, and shall acknowledge and file the certificate required by NRS 78.390 and do all things necessary to effect the amendment.

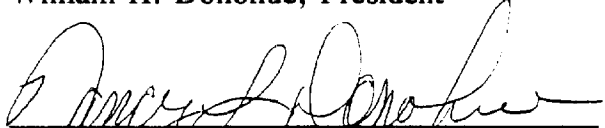
2. That following the meeting of the Board of Directors of the corporation, the following resolution was adopted on August 1, 1996 by the written consent of the stockholders of the corporation:

RESOLVED: That the amendment of Article I of the Articles of Incorporation of the corporation to change the name of the corporation to D-7 Manufacturing, Inc. as proposed by and deemed advisable by the Board of Directors in the resolution adopted by it on the first day of August, 1996, is hereby adopted and approved.

3. The stockholders entitled to vote all of the issued and outstanding stock of the corporation, consisting of 2,000 shares, consented to the amendment and no stockholder voted against such amendment.

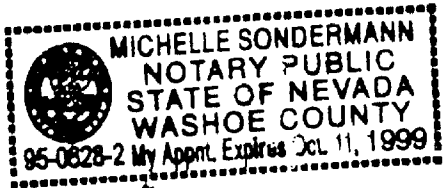
