The Assignor, on behalf of its successors, assigns and other representatives, covenants, undertakes and agrees, without further consideration, to do all such things and execute all such further assurances, applications, instruments and other documents as may be reasonably required by the Assignee to perfect this Assignment of the Trademarks to the Assignee.

The Assignor's assignment of the "Kaufman" Trademarks listed in the attached schedule shall be limited to the right to use and register such marks in association with footwear and clothing but shall not include the right to use and register such marks in association with furniture. The Assignee agrees not to use or register any of the "Kaufman" trademarks listed in the attached schedule in association with furniture.

The Assignor agrees to seek the voluntary expungement of its Canadian trademark registrations for KAUFMAN BLACK DIAMOND Design (registration No. TMA 319,829), BLACK DIAMOND KAUFMAN CANADA Design (registration No. TMA 529,854) and BLACK DIAMOND BY KAUFMAN u DESIGN (registration No. TMA 440,142).


