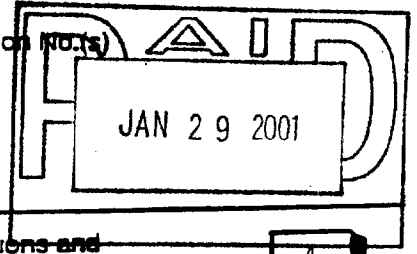

RELEASE OF TRADEMARK SECURITY AGREEMENT

14 THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of November 2000 by Firststar Bank, N.A., f/k/a Star Bank, National Association ("Bank").

WHEREAS, Bank and Gulfstream Home & Garden, Inc. ("Borrower") are parties to that certain Trademark Security Agreement dated as of September 10, 1998, which was filed with the United States Patent and Trademark Office on September 29, 1998 at Reel 1796, Frame 0148 of the Trademark Office Records.

WHEREAS, the Trademark Security Agreement granted, assigned and conveyed to Bank a security interest in Borrower's rights, titles and interest in and to all of its "Trademark Collateral" meaning, as of the effective date of the Trademark Security Agreement, all of its owned or existing and filed and acquired or arising and filed: trademarks, service marks, trademarks or service mark registrations, tradename or trademark and service mark applications, including without limitation, each mark, registration and application listed on Schedule I of the Trademark Security Agreement (attached hereto and made part hereof as Schedule I) and (i) renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payment for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all rights corresponding thereto throughout the world, (v) the Trademark License Rights as defined in the Trademark Security Agreement and (vi) together in each case with the goodwill of the Borrower's business connected with the use of and symbolized by, the Trademark Collateral.

WHEREAS, the Trademark Security Agreement provided that it would terminate upon the occurrence of certain events.

WHEREAS, Borrower has paid in full all of its Obligations to Bank, thereby satisfying the termination event set forth in the Trademark Security Agreement.

NOW, THEREFORE, Bank hereby fully releases and terminates its security interest and rights in the Trademark Collateral set forth in the Trademark Security Agreement.

Bank further agrees, at Borrower's expense, to execute and deliver to Borrower such documents as Borrower shall reasonably request to evidence such termination.

IN WITNESS WHEREOF, Bank has caused this Release of Trademark Security Agreement to be duly executed as of the day and year first above written.
