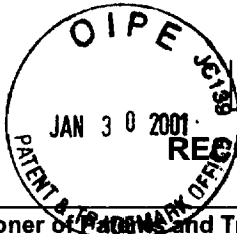

**RELEASE AND REASSIGNMENT**  
**(Trademarks, Tradenames and Service Marks)**

**THIS RELEASE AND REASSIGNMENT** (this "**Release**") is made as of June \_\_, 1999, by **FIRST SOURCE FINANCIAL LLP**, an Illinois registered limited liability partnership as successor-in-interest to **HOUSEHOLD COMMERCIAL FINANCIAL SERVICES, INC.**, a Delaware corporation ("**Lender**"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed in the Security Agreement referenced below.

**W I T N E S S E T H:**

**WHEREAS**, Lender and **MICHAELS OF OREGON CO.**, an Oregon corporation ("**Borrower**") are parties to a certain Trademark Agreement (the "**Security Agreement**"), pursuant to which Borrower has granted a security interest to Lender in, and a collateral assignment to Lender of, among other things, the Released Trademarks (as defined below); and

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby releases its security interest in all of Borrower's right, title and interest in and to all of the following assets (all of which being hereinafter referred to as the "**Released Trademarks**"):

All foreign and United States (including, without limitation, each individual state thereof) trademarks and trademark registrations, tradenames and tradename registrations and service marks and service mark registrations and applications therefor now or hereafter owned by Borrower, including, without limitation, those listed on Schedule I hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark and trademark registration, tradename and tradename registration, service mark and service mark registration and applications therefor and all continuations and extensions thereof, the right to sue for

past, present, and future infringements or dilutions thereof or for injury to the goodwill associated therewith, all rights corresponding thereto throughout the world, and all proceeds of the foregoing, including, without limitation, licenses, royalties and proceeds of suit.


