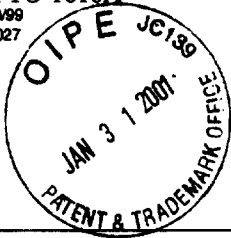

ASSIGNMENT

at no expense to Assignor, execute additional lawful papers and generally do all other lawful acts reasonable and necessary to record this Assignment.
