**CONTRIBUTION AGREEMENT**

**between**

**ZOZA.COM CORPORATION**

**and**

**ZOZA, INC.**

This CONTRIBUTION AGREEMENT ("Agreement") is made effective as of December 29, 2000, (the "Agreement Date") by and between ZoZa.com Corporation ("ZoZa.com"), a Delaware corporation, and ZoZa, Inc. ("ZoZa, Inc."), a Delaware corporation.

**RECITALS**

**WHEREAS, ZoZa, Inc. is a newly formed corporation, with no assets or liabilities as of the date hereof; and**

**WHEREAS, ZoZa.com desires to contribute certain assets to ZoZa, Inc. in exchange for one hundred percent of the issued shares of stock in ZoZa, Inc. and ZoZa, Inc. has agreed to accept those assets of ZoZa.com on the terms and subject to the conditions set forth in this Agreement.**

**AGREEMENT**

**NOW, THEREFORE, in consideration of the mutual promises, covenants and obligations contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:**

**1.0 CONTRIBUTION OF ASSETS**

**1.1 Capital Contribution. On December 29, 2000, effective as of the Agreement Date, ZoZa.com shall make a capital contribution to ZoZa, Inc. of all tangible property as described in Exhibit A and intangible property as described in Exhibit B to this Agreement ("Transferred Property"). ZoZa, Inc. shall accept and receive from ZoZa.com, all rights, title, and interest in each and all of the Transferred Property, intending hereby to convey to ZoZa, Inc. all of the right, title, interest (legal or equitable), covenants, undertakings and obligations, contingent, deferred or otherwise, of ZoZa.com in and to the Transferred Property, to have and hold the Transferred Property hereby, assigned, transferred, conveyed and delivered to ZoZa, Inc. for its use and benefit forever, provided, however, that ZoZa, Inc. shall not assume any indebtedness whether or not associated with the Transferred Property.**

**2.0 CONSIDERATION**

2.1 Consideration. In consideration for the Transferred Property, upon execution of this Agreement, ZoZa, Inc. will issue and register in the name of ZoZa.com one hundred percent of the issued shares of stock in ZoZa, Inc. (the "Shares"). The Shares are fully paid and nonassessable. ZoZa.com hereby acknowledges receipt from ZoZa, Inc. of a stock certificate evidencing the Shares.

**3.0 REPRESENTATIONS AND WARRANTIES OF ZOZA, INC.**

ZoZa, Inc. hereby represents and warrants to ZoZa.com as follows:

3.1 ZoZa, Inc. is a corporation duly organized, validly existing and in good standing under the laws of the State of Delaware.

3.2 ZoZa, Inc. has full power and authority to enter into this Agreement, and to carry out the transactions contemplated hereby and thereby. The Board of Directors of ZoZa, Inc. has taken all action required to authorize the execution, delivery and performance of this Agreement, and the consummation of the transactions contemplated hereby and thereby. This Agreement has been duly and validly authorized, executed and delivered by ZoZa, Inc., and constitutes a valid and binding obligation of ZoZa, Inc. enforceable against it in accordance with its terms.

3.3 The execution, delivery and performance by ZoZa, Inc. of this Agreement does not and will not (i) violate or breach ZoZa, Inc.'s governing documents, (ii) violate or conflict with any applicable law, provided that any requirement for consent, authorization, license, permit, registration or approval by governmental agencies or third parties have been or will be obtained or that any requirement for notification to such parties have been complied with, (iii) violate, breach, cause a default under or otherwise give rise to a right of termination, cancellation or acceleration with respect to (presently, with the giving of notice or the passage of time) any material agreement, contract or instrument to which ZoZa, Inc. is a party or by which any of its assets is bound, provided that any requirement for consent, authorization or approval by third parties have been or will be obtained or that any requirement for notification to such parties have been complied with, or (iv) result in the creation or imposition of any lien, pledge, mortgage, claim, charge or encumbrance upon any assets of ZoZa, Inc.

3.4 Any consent, authorization, license, permit, registration or approval of, or exemption or other action by, any governmental authority or any third parties or any notification to such parties required in connection with ZoZa, Inc.'s execution and delivery of this Agreement or with the performance by ZoZa, Inc. of its obligations hereunder or thereunder shall be obtained by ZoZa, Inc., within reasonable time following the execution of this Agreement, unless otherwise agreed between the parties.

**4.0 REPRESENTATIONS AND WARRANTIES OF ZOZA.COM**

ZoZa.com hereby represents and warrants to ZoZa, Inc. as follows:

4.1 ZoZa.com is a corporation duly organized, validly existing and in good standing under the laws of the State of Delaware.

4.2 ZoZa.com has full corporate power and authority to enter into this Agreement, and to carry out the transactions contemplated hereby and thereby. The Board of Directors of ZoZa.com has taken all action required to authorize the execution, delivery and performance of this Agreement, and the consummation of the transactions contemplated hereby and thereby. This Agreement has been duly and validly authorized, executed and delivered by ZoZa.com, and constitutes a valid and binding obligation of ZoZa.com enforceable against it in accordance with its terms.

4.3 The execution, delivery and performance by ZoZa.com of this Agreement does not and will not (i) violate or breach ZoZa.com's governing documents, (ii) violate or conflict with any applicable law, provided that any requirement for consent, authorization, license, permit, registration or approval by governmental agencies or third parties have been or will be obtained or that any requirement for notification to such parties have been complied with, (iii) violate, breach, cause a default under or otherwise give rise to a right of termination, cancellation or acceleration with respect to (presently, with the giving of notice or the passage of time) any material agreement, contract or instrument to which ZoZa.com is a party or by which any of its assets is bound, provided that any requirement for consent, authorization or approval by third parties have been or will be obtained or that any requirement for notification to such parties have been complied with or will be complied with, or (iv) result in the creation or imposition of any lien, pledge, mortgage, claim, charge or encumbrance upon any assets of ZoZa.com.

4.4 Any consent, authorization, license, permit, registration or approval of, or exemption or other action by, any governmental authority or any third parties or any notification to such parties required in connection with ZoZa.com's execution and delivery of this Agreement or with the performance by ZoZa.com of its obligations hereunder or thereunder shall be obtained by ZoZa.com, within reasonable time following the execution of this Agreement, unless otherwise agreed between the parties.

4.5 ZoZa.com is acquiring the Shares for investment for its own account and not with a view to, or for resale in connection with, any public distribution, and understands that such stock has not been registered under the Securities Act of 1933, as amended (the "Securities Act"), by reason of a specific exemption from the registration provisions of the Securities Act which depends upon, among other things, the bona fide nature of the investment intent as expressed herein.

## 5.0 GENERAL

5.1 Entire Agreement. This Agreement constitutes the entire agreement between the parties concerning the subject matter hereof and supersedes all prior statements, representations, discussions, negotiations and agreements, both oral and written.

5.2 Amendment or Waiver. This Agreement may not be amended or modified except in a writing signed by authorized officers of both parties.

5.3 Illegal or Unenforceable Provisions. In the event that any one or more of the provisions of this Agreement shall be found to be illegal or unenforceable, this Agreement shall nevertheless remain in full force and effect, and such term or provision shall be deemed severed.

5.4 Force Majeure. No default, delay or failure to perform on the part of either party shall be considered a breach of this Agreement if such default, delay or failure to perform is shown to be caused by any event constituting force majeure, or causes beyond the reasonable control of the defaulting party, including without limitation war, embargo, severe weather, fire, or earthquake, provided that the party so relieved of its obligations shall take steps to prevent, correct or amend such act or event which renders such obligations impossible.

5.5 Further Assurances. The parties agree to do all such things and to execute such further documents as may reasonably be required to give full effect to this Agreement.

5.6 Governing Law. This Agreement shall be governed by and construed in accordance with the laws of Delaware.

5.7 Headings. The descriptive headings contained herein are for convenience only and shall not control or affect the meaning, interpretation or construction of any provision of this Agreement.

5.8 Post-Transfer Covenant. The parties agree that in case at any time after the Agreement Date any further action is necessary to carry out the purposes of this Agreement, ZoZa.com and ZoZa, Inc. shall take further action including the execution and delivery of instruments and documents as either ZoZa.com or ZoZa, Inc. may request.
