TRADEMARK ASSIGNMENT

WHEREAS, SNE Enterprises, Inc., a Delaware corporation, with a principal address at One Wausau Center, Wausau, Wisconsin 54403 (hereinafter "Parent-Assignor") owns the mark AWC and has validly obtained subsisting U.S. Trademark Registration No. 1,969,993 therefor registered on April 23, 1996 (hereinafter "Registered Trademark");

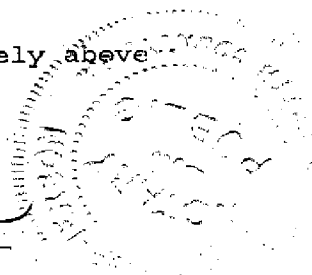

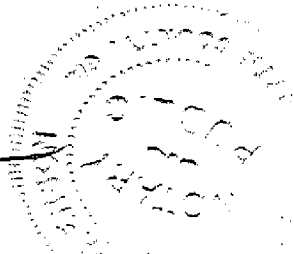
