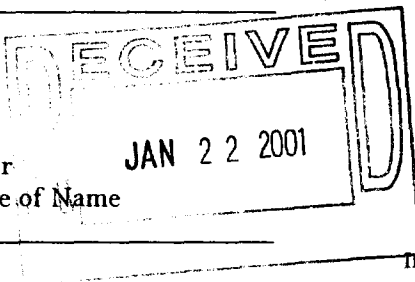

WHEREAS, Assignor has agreed to convey the Trademark and all associated goodwill in the Trademark to Assignee for good and valuable consideration;




