## GPI SAVE-ON-FOODS ASSIGNMENT


FOR VALUE RECEIVED, the receipt and sufficiency of which are hereby acknowledged, Great Pacific Industries Inc. (mistakenly referred to as "Great Pacific Industries, Ltd." in U.S. registration no. 1,997,783), a Canadian corporation ("Assignor"), hereby sells, transfers, assigns and conveys to American Stores Company, a Delaware corporation ("Assignee"), its successors and assigns, its entire right, title and interest in and to the U.S. SAVE-ON-FOODS mark (including the variation thereof where "\$" is substituted for the letter "S") (the "U.S. Mark") for retail grocery store and supermarket services and for any other goods or services in connection with which Assignor has acquired rights in the U.S. Mark in the U.S. in connection with the provision of services and sale of goods in the U.S., including any common law rights or any rights inuring to the benefit of Assignor under any license agreement, together with the goodwill associated with such use of the U.S. Mark in the U.S., U.S. registration no. 1,997,783 on the Principal Register for SAVE-ON-FOODS, and the right to sue and recover damages and profits for past infringements of the Mark in the U.S.

Assignor agrees to cooperate, at Assignee's expense, with Assignee or any successor thereof by executing and delivering any documents that may be necessary to protect, preserve or perfect Assignee's rights in the Mark. This Trademark Assignment shall inure to the benefit of Assignee, its successors and assigns, and be binding upon Assignor, its successors and assigns.
